This authorization does not have a specific geographical scope, so THE PHOTOGRAPHER and other natural or legal persons to whom THE PHOTOGRAPHER may transfer the exploitation rights over the photographs, or parts thereof, in which I intervene as a MODEL, may use those photographs, , or parts thereof, in all countries of the world without geographical limitation of any kind.

This authorization refers to all uses that the photographs, or parts thereof, in which I appear as a MODEL may have, using the technical means currently known and those that may be developed in the future, and for any application. All of this with the only exception and limitation of those uses or applications that could violate the right to honor in the terms provided for in Organic Law 1/85, of May 5, on Civil Protection of the Right to Honor, Personal and Family Intimacy. and to the Image itself.

This authorization does not set any time limit for its granting or for the exploitation of the photographs, or part of them, in which I appear as a MODEL, so my authorization is considered granted for an unlimited period of time.

The photos could be reduced for delivery to the models, if they would like to make a different use, such as using them to publish and/or sell them digitally or analogically, they must contact the author of the photos and reach an agreement between both parties.

### ECONOMIC COMPENSATION(S)
